1. Pursuant to the New HR methodology for induction of Agniveervayu under 'Agnipath Scheme', aimed to provide an opportunity to Nation's youth to experience military way of life for a period of four years, <u>Indian Air Force invites ONLINE applications from unmarried Indian male and female candidates for selection test from 22 March 2025 onwards to join the IAF as an AGNIVEERVAYU</u>. The number and employability of female candidates will be decided as per service requirement.

#### (THE SELECTION TEST IS NOT FOR SELECTION AS COMMISSIONED OFFICERS/ PILOTS/ NAVIGATORS/ AIRMEN)

2. Application is required to be filled only ONLINE by the candidates and detailed instructions to fill up the same are available at <a href="https://agnipathvayu.cdac.in">https://agnipathvayu.cdac.in</a>.

3. This examination is valid for AGNIVEERVAYU INTAKE 01/2026.

4. ONLINE REGISTRATION shall commence at 1100 Hr on 07 January 2025 and will close at 2300 Hr on 27 January 2025. Only ONLINE REGISTERED applications shall be accepted. For registration log on to https://agnipathvayu.cdac.in.

Note. Candidates are advised to register at the earliest opportunity as no extension of registration dates will be accommodated.

#### ELIGIBILITY CRITERIA

5. <u>Age</u>.

(a) Date of Birth Block. Candidates born between 01 January 2005 and 01 July 2008 (both dates inclusive) are eligible to apply.

(b) In case, a candidate clears all the stages of the Selection Procedure, then the **upper age limit as on date of enrolment should be** 21 years.

6. <u>Marital Status and Pregnancy</u>. Only unmarried candidates (male & female) will be eligible for enrolment as Agniveervayu and they shall undertake not to marry during the defined engagement period of four years. Keeping in view limited period of engagement of Agniveervayu inclusive of training, skill development activities, practical as well as formative assessment and organisational requirement of continued service of Agniveervayu during the engagement period will adversely affect the operational efficiency of the Indian Air Force. Agniveervayu who marry during the said period shall be discharged from the service. Further, only unmarried Agniveervayu will be eligible for Selection in regular cadre as Airman. Female candidates additionally shall be required to undertake not to get pregnant during the engagement period of four years. Such women Agniveervayu on becoming Low Medical Category (LMC) due to pregnancy shall liable to be discharged from service. Pregnancy will debar the women Agniveervayu for selection into Regular Cadre. At the time of enrolment, candidates shall require to sign a voluntary undertaking accepting above conditions.

# 7. Educational Qualification

(a) <u>Science Subjects</u>.

Candidates should have passed Intermediate/ 10+2/ Equivalent examination with Mathematics, Physics and English from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

OR

Passed Three years Diploma Course in Engineering (Mechanical/ Electrical/ Electronics/ Automobile/ Computer Science/ Instrumentation Technology / Information Technology) from Central, State and UT recognized Polytechnic institute with 50% marks in aggregate and 50% marks in English in Diploma Course (or in Intermediate/Matriculation, if English is not a subject in Diploma Course).

OR

Passed Two years Vocational Course with non-vocational subject viz. Physics and Mathematics from Education Boards recognized by central, State and UT with 50% marks in aggregate and 50% marks in English in Vocational Course (or in Intermediate / Matriculation, if English is not a subject in Vocational Course).

#### (b) Other than Science Subjects.

Passed Intermediate / 10+2 / Equivalent Examination in any stream/subjects from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

OR

Passed two years Vocational Course from Education Boards recognized by Central, State and UT with minimum **50% marks** in aggregate and **50 marks** in English in Vocational Course (or in Intermediate / Matriculation if **English is not a** subject in Vocational Course).

Weight. Weight should be proportionate to height and age as applicable for IAF.

(c) <u>Chest</u>.

(b)

(i) <u>For Male candidates</u>. The chest wall should be well proportioned and well developed. Minimum chest circumference should be **77 cms** and the chest expansion should be atleast **05 cms**.

(ii) <u>For Female candidates</u>. The chest wall should be well proportioned and should be with minimum range of expansion of **05 cms**.

(d) <u>Hearing</u>. Candidate should have normal hearing i.e. able to hear forced whisper from a distance of 6 meters by each ear separately.

(e) <u>Dental</u>. Should have healthy gums, good set of teeth and minimum 14 dental points.

(f) <u>General Health</u>. Candidate should be fit for the Air Force, must conform to the medical standards and should be of normal anatomy without loss or deformity of any appendages. He / She should be free from any active or latent, acute or chronic, medical or surgical disability or communicable disease, infection and skin ailments. Candidate shall be physically and mentally FIT to perform duty in any part of the world, in any climate and terrain.

(g) <u>Gynaecological Examination (For female candidates)</u>. The examination covers external genitalia, hernia orifices and the perineum, any evidence of stress urinary incontinence or genital prolapse outside introitus.

(h) <u>Gender</u>. Any candidate if found to have predominant characteristics of the opposite gender as evident on external physical examination, will be rejected as **Unfit**. Any candidate having undergone gender reassignment surgery will be declared **Unfit**.

(j) (j) (For female candidates). Any candidate, if found pregnant shall be disqualified and her candidature will be rejected.

(k) <u>Body Tattoo</u>. Permanent body tattoos are not permitted. However, tattoos only on inner face of the fore arms (inside of elbow to the wrist), back (dorsal) part of the hand/reverse side of palm and Tribals with tattoos which are as per custom and traditions of their tribes may be considered. Offensive, obscene, indecent, sexist or racist tattoos are prohibited regardless of location on the Body. However, right to consider a tattoo acceptable or unacceptable will rest with the Selection Centre. Candidates with permanent body tattoos are to submit two postcard size photographs (close up and distant view) with details of size and type of the Tattoo.

#### Note.

(i) Candidates should bring latest prescription (not older than one month) and spectacles for corrected vision, if used. The prescription must bear the dioptre measurement, name, signature, stamp and registration number of Ophthalmologist. Date of prescription should be within a month prior to appearing for medical examination.

- (ii) Corneal Surgery (LASIK/PRK) is not acceptable.
- (m) Details of medical standards are available on CASB web portal <u>https://agnipathvayu.cdac.in</u>.

10. <u>Consumption of Narcotic Drugs and Psychotropic Substance (NDPS)</u>. Consumption of Narcotic Drugs and Psychotropic substances banned under the NDPS Act 1985 shall be a reject criteria for selection into the IAF. AGNIVEERVAYU found either in possession or storing or distributing or consuming such drugs and substances after enrolment shall be liable for disciplinary action including dismissal from the IAF. ZERO TOLERANCE POLICY TO ALCOHOLISM AND SUBSTANCE ABUSE IS FOLLOWED IN IAF.

11. **Only Sikh candidates**, whose religion prohibits cutting of hair or shaving of face, shall be permitted to grow hair and/ or retain beard and moustache. Accordingly, those Sikh candidates willing to retain the same as per laid down specification are to get their photographs with beard and moustache.

#### TERMS AND CONDITIONS

12. Agniveervayu will be enrolled in the Indian Air Force under Air Force Act 1950, for a period of **FOUR years**. Agniveervayu would form a distinct rank in the Indian Air Force, different from any other existing ranks. The Indian Air Force is not obliged to retain Agniveervayu beyond the engagement period of four years.

<u>Note – 1</u>. Candidates eligible for Science Subjects examination (Including Intermediate/ 10+2/ three years diploma course in engineering or two years vocational course with non-vocational subjects of Physics and Maths) are also eligible for Other than Science Subjects and would be given an option of appearing in both Science Subjects and Other than Science Subjects examination in one sitting while filling up the online registration form.

<u>Note – 2</u>. Education Boards recognized by Central, State and UT as on date of registration shall only be considered.

Note – 3. Exact aggregate Percentage of marks before decimal as written in the marks sheet of 10+2/ Intermediate/ Equivalent Examination/ Three years Diploma Course/ Two years Vocational Course OR calculated as per the rules of concerned Education Board / Polytechnic Institute shall only be considered (For example 49.99% should be taken as 49% and not to be rounded off to 50%).

8. <u>Domicile Category</u>. Candidates have to choose one of the domicile categories mentioned below and declare the same as their domicile state/ UT in the domicile column in the online application form at the time of online registration. They are also required to upload the relevant Domicile Certificate/ COAFP Certificate as per the category chosen. The following are the categories of domicile :-

(a) <u>Permanent Domicile</u>. Permanent Domicile of the districts of State(s)/ UTs. The candidate shall produce 'Domicile Certificate' issued by any Gazetted Officer in Revenue Department or any other official authorized by the State Government of the particular State/ UT.

(b) <u>COAFP</u>. Children of serving Air Force personnel [Officers/ Airmen/ NCs(E) and Unit cadre Civilians paid from Defence Estimates] whose father/ mother is presently serving in any Air Force Unit/ any other Organisation located in the districts of State(s)/ UTs. Such candidates will produce latest COAFP (Children of Air Force Personnel) Certificate.

(c) <u>COAFP</u>. Children of Air Force personnel [Officers/ Airmen/ NCs(E) and Unit Cadre Civilians paid from Defence Estimates] whose father/ mother is Retired/ Discharged/ Deceased and they are residing in the districts of State(s)/ UTs. Such candidates will produce a proof of minimum stay of one year along with original and photocopy of Service Book/Discharge Book/ Casualty Service Certificate/ Service Particular Certificate (issued from DPO-3/ DAV as applicable) in case of Officers/ Airmen/ NCs(E) and a Certificate duly signed by OIC Civil Admin and counter signed by CO/ C Adm O of the last served unit, in case of Civilians.

<u>Note</u>. Domicile Category once chosen will not be changed later as the same will be applicable to the candidate at the time of shortlisting for Phase-II exam and preparation of Provisional Select List (PSL) which will be done state-wise as per the vacancies allocated for each state/ UT. As per the category chosen during registration, candidate will be required to produce relevant original Domicile Certificate/ COAFP Certificate (if shortlisted for Phase-II Exam) for every stage of selection till enrolment.

9. Mandatory Medical Standards. General Medical Standards for AGNIVEERVAYU male & female candidates are as follows :-

(a) <u>Height</u>.

(i) For Male candidates. Minimum acceptable height is 152 cms.

(ii) <u>For Female candidates</u>. Minimum acceptable height is **152 cms**. For candidates belonging to North East or hilly regions of Uttarakhand, a lower minimum height of **147 cms** will be accepted. In case of candidates from Lakshadweep, the minimum height will be **150 cms**.

Note. Candidates availing height relaxation for being domicile of North East/ Hilly Regions of Uttarakhand/ Lakshadweep are to submit domicile certificate with endorsement of domicile status at the time of Phase-II testing. Further, candidates from hilly regions of Uttarakhand must have specific endorsement of hilly region in their domicile certificate.

13. On completion of four years of service, based on organisation's requirements and policies promulgated by the Indian Air Force, Agniveervayu will be offered an opportunity to apply for enrolment in the regular cadre of the Indian Air Force as Airmen. These applications will be considered in a centralised manner based on objective criteria, including performance during their four-year engagement period and up to 25% of each specific batch of Agniveervayu will be enrolled in regular cadre of IAF. Agniveervayu will not have any right to be selected for further enrolment into the Indian Air Force. Selection of the Agniveervayu for further enrolment, if any, shall be at the discretion of the Government of India.

14. <u>Employability</u>. Agniveervayu enrolled under this entry are liable to be assigned any duty in organisational interest at the discretion of the Indian Air Force.

15. Training. On being enrolled, Agniveervayu will be imparted military training based on Indian Air Force requirements.

16. Leave. Grant of leave will be subject to exigencies of the Indian Air Force. The following leave is applicable for Agniveervayu during their engagement period :-

- (a) <u>Annual Leave</u>. 30 days per year.
- (b) Sick Leave. Based on medical advice by competent Medical Authority.

17. <u>Medical and CSD Facilities</u>. For the duration of their engagement period in the Indian Air Force, Agniveervayu will be entitled for medical facility at Service Hospitals as well as CSD provisions.

18. Pay, Allowances and Allied Benefits. Agniveervayu enrolled under this Scheme will be paid an Agniveer package of ₹30,000/- per month with a fixed yearly increment. In addition, Risk and Hardship allowances (as applicable in IAF), Dress and Travel allowances will be paid. Perks such as ration, clothing, accommodation and Leave Travel Concession (LTC) shall also be provided as per the existing rules.

19. <u>Terminal Benefits - Seva Nidhi Package</u>. AGNIVEERVAYU will be given one time 'Seva Nidhi' package comprising of their monthly contribution along with matching contribution by the Government on completion of their engagement period, as indicated below :-

Note 1. AGNIVEERVAYU will not be required to contribute to any Provident Fund in Indian Air Force.

Note 2. There shall be no entitlement to gratuity and any kind of pensionary benefits.

Insurance, Death and Disability Compensation. AGNIVEERVAYU will be provided non-contributory Life Insurance cover of ₹ 48 Lakhs for the 20. duration of their engagement period as AGNIVEERVAYU in the Indian Air Force. AGNIVEERVAYU will not be governed by provisions contained in the Pension Regulations/ Rules for Indian Air Force. For details of Death/ Disability compensation log on to https://agnipathvayu.cdac.in.

21. Agniveer Skill Certificate. At the end of engagement period, a detailed Skill-Set certificate will be provided to the AGNIVEERVAYU, highlighting the skills and level of competency acquired by the personnel during their engagement period.

Not Entitled to the ESM Status. Agniveervayu enrolled under this Scheme will not be eligible for Ex-Servicemen status after their discharge from 22. the Service on completion of four years engagement period.

23 Agniveervayu will not be permitted to appear in any examination for commissioning in Army/Navy/IAF during the engagement period of four years unless he/ she has applied for said exam before getting enrolled.

24 Release at own request prior to completion of engagement period will not be permissible for Agniveervayu. However, in exceptional cases, personnel enrolled as Agniveervayu may be released, with approval of the Competent Authority.

#### SEQUENCE OF EXAMINATION

#### MOBILE PHONES / SMART WATCHES / ELECTRONIC DEVICES ARE PROHIBITED IN TESTING AREAS DURING PHASE-I AND PHASE-II. CANDIDATES FOUND IN POSSESSION OF MOBILE PHONES/ ELECTRONIC DEVICES SHALL BE DEBARRED PERMANENTLY

Phase-I

Online Test. Eligible candidates will be sent admit cards for Phase - I of testing on their registered e-mail IDs between 48-72 hrs prior to the 25. examination. Candidates are required to download the admit card, take a colour printout and carry the same to the examination centre. Name of city & exam date will be intimated to the candidates at an earlier date to enable them to plan their movement. This provisional admit card can also be downloaded by the candidate under candidates login on CASB web portal https://agnipathvayu.cdac.in. All candidates in possession of provisional admit card will undertake Online Test at centres designated / allotted as per their admit card. Online test will be objective type and questions will be bilingual (English & Hindi) except for English paper. Candidates are to bring one blue / black pen and original AADHAAR card along with them for Phase - I testing. Details of the test are as follows :-

Science Subjects. Total duration of the online test shall be 60 minutes and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus.

Other than Science Subjects. Total duration of the online test shall be 45 minutes and shall comprise of English as per 10+2 CBSE (b) syllabus and Reasoning & General Awareness (RAGA).

Science Subjects & Other than Science Subjects. Total duration of the online test shall be 85 minutes and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RAGA).

- Marking pattern for online test :-(d)
  - One mark for every correct answer. (i)
  - (ii) Nil (0) marks for unattempted guestion.
  - (iii) 0.25 marks shall be deducted for each wrong answer

Note. Above examination methodology has been designed to facilitate selection process based on qualifications of candidates. Irrespective of the examination methodology AGNIVEERVAYU enrolled under this entry are liable to be assigned any duty in organisational interest, at the discretion of the Indian Air Force.

Marks scored by the candidates in STAR Phase-I Testing will be "Normalised" by using the formula as published on the web site 26. https://agnipathvayu.cdac.in, to take into account variation in difficulty levels of the question papers across different sessions. Candidates are to note that the application of Cut-Off for shortlisting of candidates for STAR Phase-II testing and preparation of Final Merit List for selection will be based on "Normalised Marks" and not on the "Actual Marks" scored by the candidate in STAR Phase-I testing. Further, on normalisation, marks scored by a candidate in a subject may become less/more than actual marks, and more than total marks of that subject in exceptional cases. Shortlisting for Phase-II testing will be carried out in state-wise manner. The Cut-Off marks for shortlisting for Phase-II testing may vary from state to state as vacancies have been allocated in a state-wise manner.

CANDIDATES ARE TO QUALIFY IN EACH PAPER INDIVIDUALLY IN SCIENCE SUBJECTS AND OTHER THAN SCIENCE SUBJECTS, with 27 normalised marks. The result of Phase-I and state-wise shortlisting for Phase-II, based on their performance in Phase-I online test, will be uploaded in candidate's individual log in ID on https://agnipathvayu.cdac.in.

#### Phase - I

Soon after the declaration of the result of Phase-I (Online) Test, a cut off will be applied on the normalised marks scored by the candidates in the 28. Phase-I Test and state-wise SHORTLISTED candidates will be sent a new Admit Card on their registered e-mail IDs for Phase-II test at a designated ASC as per their domicile category chosen at the time of registration (refer para 8). This Admit Card for Phase-II exam can also be downloaded online under candidate's login on CASB web portal https://agnipathvayu.cdac.in. Candidates have to report on the stipulated date and time for Phase-II at the designated ASC along with following :

- Colour print out of Phase-II Admit Card. (a)
- (b) Colour print out of duly filled application form downloaded on completion of online registration.
- HB pencil, eraser, sharpener, glue stick, stapler and black/blue ball point pen for writing. (c)
- Eight copies of un-attested passport size colour photograph (which was used for the online application registration). (d)

Original and four self-attested photocopies of matriculation passing certificate (required for verification of candidate's name, father's (e) name and his/her date of birth)

Original and four self-attested photocopies of matriculation marks sheet (only applicable for three years Diploma/ two years Vocational Course holders when English is not a subject in Diploma/Vocational Course).

Original and four self-attested photocopies of Intermediate/10+2/equivalent examination passing certificate and marks sheet. (g)

OR

Original and four self-attested photocopies of three years diploma course passing certificate and marks sheets of all semesters.

#### OR

Original and four self-attested photocopies of two years Vocational Course passing certificate and all marks sheets including non-vocational course with subjects English, Physics and Mathematics.

Original and four self-attested photocopies of Domicile Certificate/ COAFP Certificate. The candidate shall produce the chosen 'Domicile Certificate' (issued by any Gazetted Officer in Revenue Department or any other official authorized by the State Government of the particular state/ UT) or COAFP Certificate while reporting for Phase-II examination.

The original passing certificates/marks sheets shall not be retained by the selection centre. The same shall be returned to the Note-3. candidates on completion of detailed verification.

Internet copy of marks-sheet are not acceptable. Note-4

Candidates are strictly prohibited from doing any rough work or write anything anywhere on the Admit Cards issued for Note-5. Phase-I and Phase-II. Such candidates will be DEBARRED PERMANENTLY.

Physical Fitness Test (PFT). Names of the shortlisted candidates, who qualify the online test, shall be displayed on the CASB Web Portal 31 https://agnipathvayu.cdac.in and on a stipulated date shall be called at designated ASC for Physical Fitness Test (PFT) and Adaptability Test-II. PFT consists of two parts i.e. PFT-I and PFT-II.

PFT-I. Candidates have to complete 1.6 Kms run as per the following timings to qualify for PFT-II:-

Candidates are advised to bring their sports shoes and shorts/ track pants. Detailed procedure on expected technique for Note. Push-ups, Sit-ups and Squats is available on CASB Web Portal https://agnipathvayu.cdac.in.

32. Candidates shall sign a consent form prior to appearing in physical fitness test/ medical test for selection in IAE. He / She shall appear in these tests at his / her own risk and shall not be paid any compensation by IAF for injury/ casualty if any, sustained by him / her during such tests. The consent form shall be signed by parents/ guardian of candidates below 18 years of age. The consent form is appended with Phase-II Admit Card.

Adaptability Test-1. All candidates who pass the Physical Fitness Test (PFT) shall have to undertake Adaptability Test-1 (objective type written 33 test) which is to assess suitability of a candidate for employment in the IAF which involves deployment in varied geographic terrain, weather and operational conditions

34. Adaptability Test-II. All candidates who pass Adaptability Test-I will have to undertake Adaptability Test-II as per policy in vogue. Adaptability Test-II is for selection of candidates who can adapt to the environment of the Indian Air Force and are able to adjust to the military way of life.

#### <u>Phase – Ill</u>

Medical Examination. Candidates who qualify Adaptability Test-II shall be issued with medical appointment letter by respective ASCs. Medical examination shall be conducted by Air Force Medical Team as per IAF medical standards and policy in vogue on subject issue. Medical examination would also include Baseline Investigations of :-

- Blood Haemogram Hb, TLC, DLC, Platelets.
- (b) Urine RE/ME.
- (c) Biochemistry :-
  - Blood Sugar Fasting/Post Prandial. (i)
  - Serum Cholesterol. (iii)
  - RFT- Serum Urea, Uric Acid, Creatinine. (iv) LFT- Serum Bilurubin, SGOT, SGPT.
- Radiograph Chest (PA view).
- (d) Ultrasonography of lower abdomen & Pelvis (For female candidates only). (e)
- ECG (R). (f)
- Any other investigation deemed necessary by the Recruiting Medical Officer. (a)
